The wire was run to traditional finish and times from that were published for those interested. The old communication boxes were put out but not used. There were minor issues on Saturday, but Sunday ran smoothly. We still need to update our reporting methods for end of day awards. The event was an overall success!

Nick reports that we gave away or sold all but three of the special event shirts.

Ian reports that Corey has been doing a lot of work to make this happen. We had an issue with an open mic on Saturday, but adjustments were made to transmit timers and changing channels on the radios due to local noise. With those changes, things went smoothly on Sunday. We are moving forward with getting a dedicated channel license from the FCC to avoid interference issues the future. There is also a plan to test on Sunday at Mt Washington to make sure what we have still works on the mountain.
