**Hillclimb Report:** Nick on behalf of Mike reports that the second Ascutney event is now confirmed for September 12 -13. The spring event is also confirmed and the contracts for that have been signed. No deposit was needed at this time. Ian has been working on timing and communications. We are having a meeting with those who will be involved in 2020 in January. Ian wants to setup timing kits, like the communication kits to make deployment easy. Cory is working on the FCC license. The error in our paperwork was found and resolved. They hope to have the license by next weekend. Work is being done on other upgrades such as an emergency button, upgraded headsets, and emergency lights. The wire boxes are in rough shape and could use some attention and Ian is looking for assistance with that. (George/Brittnei)

## Old Business:

**Makris Memorial Autocross:** We are considering making this an annual event, or at least making the last autocross of the year a charity-based event.

**CTTC 2020 Update:** Howard reports that registration is closed. We have over 140 applications and will accept 80 participants. The selection committee is coming together in January. There has been lots of interest in the event and we have sponsorships in the works in addition to a recently finalized deal with Cooper Tire.

## New Business

**Drivers' Championship:** We would like to bring the championship back again this year across hillclimb, autocross, tsd, etc. Drew volunteered to run it this year and Howard will help with points and weighting events. We should have some idea of what this will look like for the next meeting.

**TSD Rally:** Drew says that he will be organizing TSD events for this year. The plan is to have 3 events. Paul is planning to run one of them. There will be one in our regular TSD format, one will be in tulip form, and the other may be different than either of those. Proposed dates should be available after the next meeting.
